Built into our programme were our usual multiple informal networking opportunities, where delegates could meet each other and begin meaningful real-world collaborations that we know will produce big results.



Day 1

A star-studded program provided non-stop inspiration and insight for our guests, beginning with a very warm welcome from **Martha Delgado Peralta** – the Undersecretary for Mexico's Multilateral Affairs and Human Rights Ministry of Foreign Affairs. This opening speech was an invitation to those with an interest in investing in Mexico, creating a positive environment for our family offices and service providers to grow their ambitions in the region over the following two days.

From here we went on to hear from **Kat Echazarreta**, the first Mexican-born woman in space. Her co-stars on the first panel included Oscar-nominated film producer **Gastón Pavlovich**, explorer **Josh Bernstein**, **Match Hospitality's José Luis Font**, and **Héctor Sulaimán** of the **Scholas Foundation**. This diverse panel found common ground in the ways they bring creativity into what they do, and how they use it to pursue their professional goals.

More creative and cultural discussion followed, with a panel on art as an asset class, and a session about fostering entrepreneurship and managing innovation. This was followed by a presentation on the future of aviation technology, with an exciting look at what the future might hold for consumer air travel.

Managing conglomerates and the challenges of becoming an entrepreneur were covered by the following two panels. A presentation by Colombian serial entrepreneur **Santiago Botero Jaramillo**, **SBOLab Company Builder** followed, and then all delegates joined together for a gala dinner hosted by **Inclusive Logistics**.

Day 2

Day two began with an exploration of Latam as the sleeping giant of investment, with **David Geison**, Country Manager of **Mercado Libre Mexico & VP Marketplace Mexico**.

We then followed with a panel on impact investing and sustainability, opportunities in debt capital markets, and leveling up Latam through healthcare, before taking a networking coffee break. Mid-morning sessions were a panel on hitting the unicorn valuation, followed by a presentation on trading **Algorítmico**, and a presentation on reaching the global methane pledge by **Agrivert**.

A quick overview of our tips for the next big thing was followed by a panel on the power of diversity and inclusion in all areas of business.

Then it was time for another networking break, this time a lunch hosted by **FOREX.com**. Afternoon sessions began with a panel on private equity and venture capital, then the current state of fintech, and Web 3 cyber-security and deep tech.

The future of mobility was covered by an expert panel, and then we heard from **Nexxus Capital** and **Nexxus Iberia** on what you need to know before you take your company to public markets.

After the closing remarks and thanking our delegates and speakers, everyone headed to the final cocktail reception hosted by **alfred**.



Taking place at the stunning Four Seasons hotel in the middle of Mexico City, the summit was well placed to attract family offices and investors from around Mexico as well as being easy to reach for international delegates.
